EXTRACTS FROM BY-LAWS

Article VI – Members

Section 1. A Candidate for membership must be a member with golfing privileges of a private club in Westchester, Dutchess, Putnam or Fairfield Counties that is listed on the WSGA List of Eligible Clubs. The Board, from time to time, shall establish the WSGA List of Eligible Clubs and any such club shall have facilities adequate to host a WSGA golf tournament and dinner.

Section 2. Only such candidates as have been proposed and seconded by members of the WSGA, who are likewise members of the club to which the candidate belongs, can be elected to membership. If the candidate belongs to a club on the WSGA List of Eligible Clubs that has fewer than five WSGA members, such candidates may be proposed and seconded by WSGA members known to the candidate, from any other club on the WSGA List of Eligible Clubs.

Section 3. At the time of election, a candidate from a club on the WSGA List of Eligible Clubs shall have reached the age of fifty-five, and be a member of the club in good standing with full golfing privileges. Once admitted to membership, a member will not be affected if the club is dropped (suspended, or otherwise becomes ineligible) from the WSGA List of Eligible Clubs.

Article VII – Invitation for Membership

Section 1. Invitation for Membership shall be made on a form to be provided by the WSGA for such purpose. The Proposer and Seconder shall each write a letter to the Secretary stating the qualifications of the Candidate

Article IX – Committees and Their Duties

Section 2. The Admissions/Membership Committee shall pass upon every Invitation for Membership. The Committee may pass upon the Invitation in any order and may adopt such procedures as it may, from time to time at its discretion, consider expedient. Election to membership shall only be by the approval of the Board on Candidates recommended to it by the Admissions/Membership Committee.
